Prisons Act, 1894. No.GG/71/2016/JLM/502013/1729/J: In exercise of the powers conferred by clause (10) of sub-section(1) of section 59 read with section 5 of the Prisons Act, 1894(9 of 1894) and in supersession of all the rules made in this behalf, the Government of Gujarat hereby makes the following rules to provide for regulating the recruitment to the post of Inspector General of Prisons in the Gujarat State Jail Service Class I, in the Jail Department, namely:

- 1. These rules may be called the *Inspector General of Prisons, Class I Recruitment Rules*, 2016.
- 2. Appointment to the post of Inspector General of Prisons, in the Gujarat State Jail Service Class I in the Jail Department shall be made either -
 - (a) by promotion on the principle of selectivity within the zone of consideration irrespective of seniority in accordance with the provisions of the Gujarat Civil Services Classification and Recruitment(General) Rules, 1967 from amongst the persons who-
 - (i) have worked for not less than five years in the cadre of Deputy
 Inspector General of Prisons in the Gujarat State Jail Service
 Class I, in the Jail Department; and
 - (ii) have passed the qualifying examination for computer knowledge in accordance with the provisions of the Gujarat Civil Services Computer Competency Training and Examination Rules, 2006:

Provided that where the appointing authority is satisfied that a person having the experience specified in sub-clause (i) is not available for promotion and that it is necessary in the public interest to fill up the post by promotion even of a person having experience for a lesser period; it may, for reasons to be recorded in writing, promote such person who possesses experience of a period of not less than two-thirds of the period specified in sub-clause (i); or

(b) by temporary transfer on deputation basis from amongst the persons,-

- (i) belonging to the Indian Administrative Service or the Indian Police Service,: and
- (ii) who is in the above super time scale pay of the service to which he belongs.
