Prisons Act, 1894. No. **GG-20/2015/JLM/502013/1745/J**:- In exercise of the powers conferred by clause (10) of sub-section(1) of section 59 read with section 6 of the Prisons Act, 1894 (IX of 1894) and in supersession of all the rules made in this behalf, the Government of Gujarat hereby makes the following rules to provide for regulating the recruitment to the post of Subedar (Female). Class III, in the subordinate service of Jail Department, namely:-

- 1. These rules may be called the Subedar (Female), Class III, in Jail Department Recruitment Rules, 2015.
- 2. Appointment to the post of Subedar (Female), Class III, in the subordinate service of Jail Department shall be made either,-
 - (a) by promotion of a person of proved merit and efficiency from amongst the persons who,-
 - (i) have worked for not less than five years in the Cadre of Hawaldar (Female), Class III, in the subordinate service of Jail Department;
 - (ii) have passed the prescribed departmental examination;
 - (iii) have passed the physical efficiency test as may be prescribed by the Government; and
 - (iv) have passed the qualifying examination for computer knowledge in accordance with the provisions of the Gujarat Civil Services Computer Competency Training and Examination Rules, 2006:

Provided that where the appointing authority is satisfied that a person having the experience specified in sub-clause (i) above is not available for promotion and that it is necessary in the public interest to fill up the post by promotion even of a person having experience for a lesser period; it may, for reasons to be recorded in writing, promote such person who possesses experience of a period of not less than two-thirds of the period specified in sub-clause (i) above, or;

- (b) by direct selection.
- 3. To be eligible for appointment by direct selection to the post mentioned in rule 2, a candidate shall,
 - (a) not be less than 21 years and not be more than 35 years of age:

Provided that the upper age limit may be relaxed in favour of a candidate belonging to the Scheduled Castes, Scheduled Tribes or Socially and Educationally Backward Classes or who is already in the service of the Government of Gujarat in accordance with the provisions of the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967;

- (b) possess,-
 - (i) a degree obtained from any of the Universities or institutions established or incorporated by or under the Central or a State Act in India; or any other educational institution recognised as such or declared to be deemed as a University under section 3 of the University Grants Commission Act, 1956; or possess an equivalent qualification recognised as such by the Government;
 - (ii) the minimum requisite standards of physique as specified in Appendix annexed to these rules;
 - (iii) the basic knowledge of computer application in accordance with the provisions of the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967;
 - (iv) adequate knowledge of Gujarati or Hindi or both;
- (c) have passed the initial physical efficiency test namely, cycling, jumping, etc. held in this behalf at the time of recruitment:

Provided that preference may be given to a candidate who,-

(i) possesses 'C' certificate examination of National Cadet Corps; or

- (ii) have worked for about three years in Home Guards or Civil Defence and have also completed its refresher course and basic training; or
- (iii) have secured first, second or third rank in athletics or Yoga competition at State level or National level or any sport recognised by the State Government; or
- (iv) have participated in recognized State Level or National Level sports:

Provided further that such preference shall not exceed ten per cent of the total posts advertised for recruitment.

- 4. The candidate appointed by direct selection under rule 3 shall be appointed on contractual basis for a period of five years on such terms and conditions as prescribed by the Government Resolution, Home Department, No.JLM/502013/1745/J dated the 29th April,2015.
- 5. The candidate appointed in accordance with rule 4 shall be given the prescribed pay scale of the post of Subedar (Female), Class III, after completion of contractual period, on his performance being found satisfactory during the stipulated period of service on contractual basis.
- 6. The candidate appointed in accordance with rule 4 shall, during the stipulated period of service on contractual basis, be required to pass the CCC examination for computer knowledge in accordance with the provisions of the Gujarat Civil Services Computer Competency Training and Examination Rules, 2006.
- 7. The candidate appointed in accordance with rule 4 shall, during the stipulated period of service on contractual basis, be required to undergo prisons staff training and to pass the post-training examination in accordance with the provisions of the Gujarat Prisons Staff Training Rules, 1981.
- 8. The candidate appointed in accordance with rule 4 shall, after regular appointment, be required to pass an examination in Hindi or Gujarati or both, in accordance with the rules prescribed by the Government.
- 9. The candidate appointed either by direct selection or by promotion shall have to undergo such training and pass such examination as may be prescribed by the Government.

10. The candidate appointed by direct selection shall be required to furnish a security and a surety bond in such form, for such amount and for such period as may be prescribed by the Government.

Minimum Physical Standards for the post of Subedar (Female), Class III, in Jail Department

Physical Standards for different classes of persons.

(I) All candidates should be physically **fit** as per standards specified below:

Class	Height in Centimeters.	Weight in kilogram.
Scheduled Tribes of Gujarat origin	156	40
Candidate (Except Scheduled Tribes of Gujarat Origin)	158	40

- (II) The Candidate having any of the following physical defects shall not be fit for the post:
- (i)knock knee, (ii) pigeon Chest, (iii) Squint Eye, (iv) Flat Feet, (v) Varicose Veins, (vi) Hammer Toes, (vii) Fractured Limb, (viii) Decayed Teeth, (ix) Communicable or (x) Skin Disease.
- (III) The medical officer shall examine the candidate and issue certificate of fitness taking into consideration the Physical Standard as mentioned above and also certify

for the following matters, namely:-

- P Physical capacity for normal work
- E Eye sight
- Mean fit in all respect to perform normal professional functions under each or the above mentioned heads
